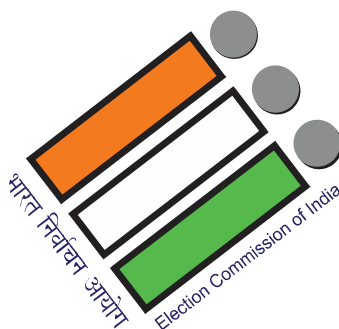

Electoral Registration Officer-in Revision beihpui neih laia amah pui turin a nghet lovin enumerator leh officer-te a ruat tlangpui a. Electoral Registration/Asst. Electoral Registration Officer-te chuan belh ngaite belhin paih ngaite an paih a; tin, tihdik ngaite an siamtha bawk a ni.

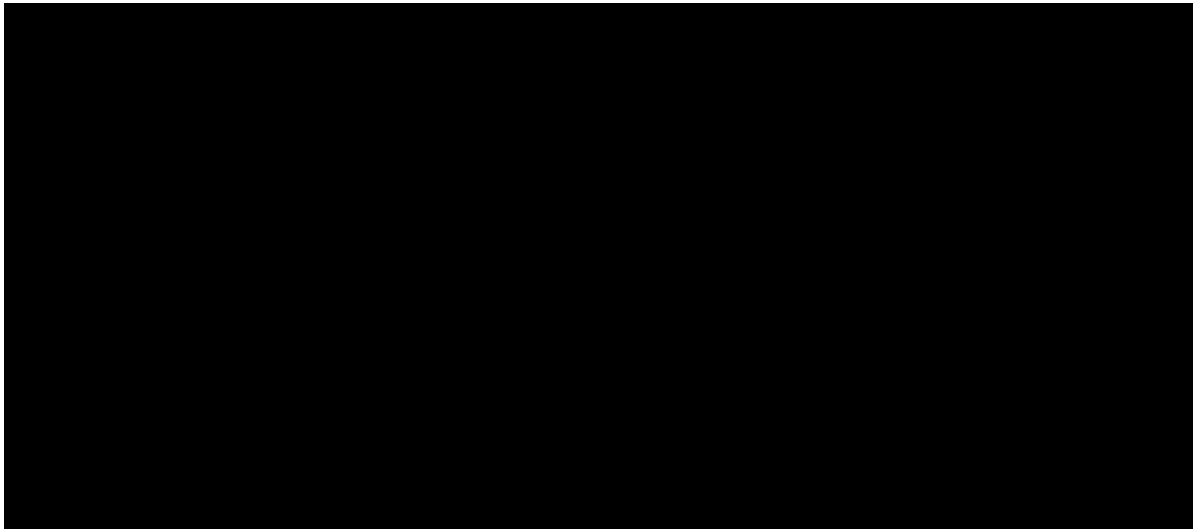
Electoral Roll-a thil fel lote siamtha turin hetih hunlaia tihdan hi a tha tawk lo tih ECI chuan a hria a. Tin, hei hian roll hlutna leh dikna a tichingpen a, chuvangin Officer tuemaw hemi hna bik atana a ngheta neih a thaa hriat a ni.

#### KUM 2006 ATANGIN

Election Commission of India chuan kum 2006 atang khan heng a chung a harsatna awmte avangin Electoral Roll leh Electoral Photo Identity Card chungchanga thudik hre tur mi Officer-te chu a ngheta neih a lo tum ta a. Ani hian Roll-a belh ngaite, paih ngaite leh siamthat ngaite a siam tha ang. He Officer hi Booth Level Officer (BLO) tih a ni ang.

**District Election Officer pawmpuinain Electoral Registration Officer-in Section 13B(2) of RP Act, 1950 hmangin Booth Level Officer-te hi a la ang a. Tichuan, appointment pek a nih chhung chu BLO chuan Section 13cc of RP Act, 1950 angin Election Commission of India/Chief Electoral Officer of the State / District Election Officer / Electoral Registration Officer / Assistant Electoral Registration Officer-te kaihhraina hnuaiah a thawk ang.**

BLO-te appointment record hi District Election Officer / Electoral Registration Officer / Assistant Electoral Registration Officer-te Office-ah fel taka Register-a dah a ni ang. Heng register-te hi a tul dana siamthat thin tur a ni ang a. Register Format chu a hnuaia mi ang hi a ni ang.



Block chuan anmahni Administration Department hnuaiah an hna an chhunzawm zel ang a. Election kaihnawih Special Campaign chung chuan District Election Officer-cum-District Magistrate hnen atanga phalna la hmasa lo chuan hmun danga sawn hmasa lo chuan hmun danga sawn emaw chawlh (leave) lak theih a ni lo ang. Engemaw vanga sawn ngai an nih emaw leave pek an nih chuan an aia thawk tur emaw siam fel tur a ni ang, a nih loh chuan hna kallai a buai thei.

Loh theih loh avanga BLO chu leave-a kal a lo ngaih a, a aia thawk tur siamfel theih a nih baw si loh chuan ama kaw register te leh lehkha pawimawhte chu ERO/AERO-ten an kaw sak tur a ni ang. Tin, District Election Officer hnen atanga phalna la hmasain ERO/AERO chuan BLO dang a la vat tur a ni ang. (Handbook Chapter 1-a “Who is a BLO and Appointment of BLO” tih en rawh).

- Composition of the House of the People. (Article 81 of the Constitution of India)
  - (a) State territorial constituencies hrang hrang atanga member 530 aia tam lo thlan chhuahte.  
State tin tana seat neih zat tur chu state chung a mipui tam dan azira pek a ni ang. Tin, State tinte chu territorial constituency-a then darh tur a ni ang a, chu constituency chung a mipui tam dan azira then a ni ang a, seat pawh chutiang bawka pek a ni ang.
  - (b) Union territory-te aiawh (represent) turin member 20 aia tam lo. (Tunah hian Union Territories atangin member 13 an awm).
- Representation of the Anglo-Indian Community in the House of the People (Article 331 of the Constitution of India) - Member 2 (pahnih) aia tam lo.

- Composition of the Legislative Assemblies:- (Article 170 of the Constitution of India).
- State tinin member 500 aia tam lo leh 60 aia tlem lo State territorial constituency hrang hrang atanga thlan chhuahte an ni ang. Hemi atan hian State tinte chu territorial con-



stituency hrang hrang an then darh ang a, an seat neih zat tur pawh constituency chhunga mipui tam dan a zira pek a ni ang.

- Special Provisions with respect to the State of Sikkim (Article 371 E (a) of the constitution of India). Sikkim Legislative Assembly chuan Member 30 aia tlem a nei tur a ni lovang.
- Special Provisions with respect to the State of Mizoram (Article 371 G (b) of the Constitution of India). Mizoram Legislative Assembly chuan member 40 aia tlem a nei tur a ni lovang.
